



Grant Announcement: 2015 Emerging Issues Partner Grant Closing the Gender Gap: Empowering Girls

Did you know that just **one in five girls** believe she has what it takes to be a leader? And, in fact, **girls'** leadership aspirations peak at age 8?

These facts and other startling statistics inspired our Emerging Issues Partner Grant Committee to focus on **girls' empowerment and leadership development**. The committee partnered with Liz Vivian (Executive Director of <u>Women's Funding Alliance</u>) to learn more about the landscape of nonprofits serving these needs.

Committee members participated in an accelerated 12-week grant making process, researching and visiting a broad array of organizations in our region. Yesterday, the Emerging Issues Partner Grant Committee announced the winner of their \$15,000 grant. The organization is:

Young Women Empowered





Young Women Empowered (Y-WE) builds young women leaders through intergenerational mentorship, intercultural collaboration, and creative programs that equip girls age 12 -18 with the confidence, resiliency, and future-planning skills they need to achieve their personal goals and improve their communities. This \$15,000 grant will allow Y-WE to increase the capacity of its Y-WE Lead program to serve even more girls.

Finalist: Girls on the Run of Puget Sound is a transformational physical activity-based, positive youth development program for girls in 3rd-5th grade that teaches life skills through dynamic interactive lessons and running games. Their proposal would support the "Heart and Sole" program, expanding services to girls in 6th-8th grades at three area middle schools.

Finalist: Reel Grrls' mission is to empower young women ages 9-21 from diverse communities to realize their power, talent and influence through hands-on workshops and classes taught by female media professionals and educators. Their proposal would expand the Mobile Program, reaching girls where they are and using more accessible technology.

About WWF Partner Grants: The <u>WWF Partner Grant process</u> is modeled on the best practices of our Pooled Fund Grant Committee, operates on a shorter, accelerated time frame, and offers an opportunity to take a more intensive look at a focused area or community. From February to May 2015, members participating on the Emerging Issues Partner Grant Committee researched Washington nonprofit organizations that are engaged in work to support girls; requested and analyzed proposals; conducted site visits; and ultimately awarded a grant of \$15,000 to Young Women Empowered.
