1 Briefly describe the organization's mission: WWF is a large scale collective giving organization that educates, inspires and increases the number of women committed to philanthropy in order to strengthen community and demonstrate the impact that can result from informed, focused grant-making.

(Revenue \$) Pooled Grant making: WWF makes five major grants to regional nonprofit organizations, one in each of these categories: arts, education, environment, health, and social services. In 2012, WWF made 5 grants totaling \$475,000, one in each area. Members invest more than 2,000 hours annually in the process, participating in a rigorous review process with the grantees ultimately selected by a vote of the membership. Merit grants totaling \$10,000 are awarded to runners up organizations.

4b (Code:) (Expenses \$ 376,600. including grants of \$ 342,210.) (Revenue \$) Individual Member Recommended Grant making: WWF members may recommend individual grants to qualified nonprofit organizations throughout the region and the country. Each member's grant recommendations are vetted to ensure that the grantees are 501(c)(3) organizations in good standing. All grants are approved by the board of directors prior to payment. In 2012, \$342,210 was granted to 246 nonprofits.

Education: WWF members participate in a broad spectrum of learning opportunities, such as educational forums, philanthropy skill-building programs and workshops, issues discussions, and "hands-on" grant making through site visits and committee work. In 2012, 51 educational events were attended by about 2,000 members and guests. We have over 200 active committee members and 2,500 volunteer hours are invested each year in educational programs.
